

DESCRIPTION OF LANDS  
LYING WITHIN SECTION 20, TOWNSHIP 35 SOUTH,  
RANGE 38 EAST, ST. LUCIE COUNTY, FLORIDA.  
(ARCCO OF ST. LUCIE STEWARDSHIP SENDING AREA - FIGURE 2C)

THE NORTH ½ OF THE SOUTHWEST ¼ AND THAT PORTION OF THE NORTHWEST ¼ AND THAT PORTION OF THE NORTH ½ OF THE NORTHEAST ¼ OF SECTION 20, TOWNSHIP 35 SOUTH, RANGE 38 EAST, ST. LUCIE COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

**COMMENCING** AT THE SOUTHWEST CORNER OF SECTION 20, TOWNSHIP 35 SOUTH, RANGE 38 EAST, ST. LUCIE COUNTY, FLORIDA.

THENCE ALONG THE WEST LINE OF SAID SECTION 20, NORTH 00°19'52" WEST 1,320.67 FEET TO THE SOUTHWEST CORNER OF THE NORTH ½ OF THE SOUTHWEST ¼ OF SAID SECTION 20, ALSO BEING THE **POINT OF BEGINNING** OF THE LANDS HEREIN DESCRIBED.

THENCE, CONTINUE ALONG THE WEST LINE OF SAID SECTION 20, NORTH 00°19'52" WEST 2,902.74 FEET;  
THENCE LEAVING SAID LINE, NORTH 89°40'08" EAST 5,140.66 FEET TO ITS INTERSECTION WITH THE WESTERLY RIGHT-OF-WAY LINE OF C-24 CANAL (VARIABLE WIDTH RIGHT-OF-WAY);  
THENCE ALONG SAID RIGHT-OF-WAY LINE, SOUTH 00°09'40" EAST 315.73 FEET TO ITS INTERSECTION WITH THE SOUTH LINE OF THE NORTH ½ OF THE NORTHEAST ¼ OF SAID SECTION 20;  
THENCE ALONG SAID LINE, NORTH 89°46'01" WEST 2,495.32 FEET TO ITS INTERSECTION WITH THE EAST LINE OF THE NORTHWEST ¼ OF SAID SECTION 20;  
THENCE ALONG SAID LINE, SOUTH 00°15'16" EAST 1,322.77 FEET TO THE CENTER OF SAID SECTION 20;  
THENCE ALONG THE EAST LINE OF THE SOUTHWEST ¼ OF SAID SECTION 20, SOUTH 00°15'16" EAST 1,324.68 FEET TO THE SOUTHEAST CORNER OF THE NORTH ½ OF THE SOUTHWEST ¼ OF SAID SECTION 20;  
THENCE ALONG THE SOUTH LINE OF THE NORTH ½ OF THE SOUTHWEST ¼ OF SAID SECTION 20, NORTH 89°33'11" WEST 2,641.23 FEET TO THE SOUTHWEST CORNER OF THE NORTH ½ OF THE SOUTHWEST ¼ OF SAID SECTION 20, ALSO BEING THE **POINT OF BEGINNING** OF THE LANDS HEREIN DESCRIBED.

PARCEL CONTAINS 194.58 ACRES MORE OR LESS.
